MINUTES: of Alderton's Annual Parish Meeting held in Alderton Village Hall on Tuesday 5 April 2022 commencing at 7.30pm.

## 1. Apologies for absence

Apologies were received from County Cllr. David Grey, Borough Cllr. John Murphy and PCSO Teresa Hiorns.

2. **Minutes of 2021 Annual Parish Meeting** were signed by the Chairman. These minutes had been approved at the Parish Council meeting held in May 2021 and any matters arising were dealt with at that meeting.

## 3. Latest Development Matters

Cllr. Page provided an update on development applications within the village.

Fresh interest had been received in relation to the land east of St. Margarets Drive – with a proposal by Rainier Homes for 60 houses. An outline planning application was anticipated by the end of May 2022.

The Cala site in front of the first development in Willow Bank Road had won on Appeal, mainly as a result of a lack of housing within Tewkesbury Borough. The groundwork for this site was expected to commence in the next 18 months.

## 4. Playing Field Update

The hire of the Changing Facility and football pitch had been affected by the pandemic, although bookings had now started to recover.

More football teams had recently expressed an interest in using the pitch. One existing team had failed to complete the 2021/22 season.

The pitch was currently in good condition although had been affected by mole activity at various times.

## 5. Allotments update

New/vacant plots were to be allocated by the end of April 2022. The Plot behind no.30 had now been cleared and rotavated so also ready to be allocated.

8 new sheds were ready to be allocated to holders of Garden Plots as soon as possible.

A parishioner raised a Health and Safety Issue relating to the fence near the allotment entrance.

Chairman responded that this matter was being investigated and would also be included as an agenda item for the next Parish Council meeting on 19 April 2022.

Neighbourhood Watch Scheme – John Williams wished to remind residents of this scheme and his direct link to the Police.

The Parish Council had been awarded £2,100 from Awards for All towards the Queen's Platinum Jubilee Celebrations, including a Village Event on Sunday 5 June 2022.
